NOTICE

18th December 2023

To all concerned

For the movement of 2 year olds i.e. 2022 born foals from Stud Farms to RWITC Ltd, either for the Annual Auction Sale 2024 or to the respective Trainer's yard at RWITC Ltd. will have to carry following documents:-

- 1) Passport of the Horse
- Valid EIA negative certificate (validity period- 120 days from date of Blood collection)
- 3) Valid GLANDERS negative certificate from DRL, Pune or NRCE, Hissar (validity period 30 days from date of Blood Collection)
- 4) A Health Certificate from a Veterinary Officer stating that the horse neither suffered nor showed any infectious diseases like EIA, Glanders, African Horse Sickness and Dourine, etc.
- Horses should have been administered with primary course of Fluvac Innovator EHV-4/1 of at least two doses given in accordance with the manufacturer's recommendation but not within 7 days (as against 14 days) of arrival and bearing the vaccination certificate with details of the date of vaccination, name of vaccine, batch number, expiry date and duly signed/endorsed by either Chief Veterinarian or Panel Veterinarian in the passport/ identity certificate.
