#### **ALL BREEDING ESTABLISHMENTS**

##### **Covering Results - Imported Mares**

1. Covering results of imported mares in India in 2017/2018 have to be informed by us to the Stud Book Authorities abroad within the stipulated time. Therefore, breeders are requested to kindly provide this information by **15 Jul 2018**.
2. This information **need not be sent** for mares whose Notifications of Birth, foals casualties or pregnancy casualties have already been submitted.

##### **Debit In Stud Accounts**

3. Breeding Establishments whose Accounts are in debit are requested to clear the same at the earliest. Registration of documents submitted by Breeding Establishments whose accounts are in debit will be processed in terms of Para 122 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India, effective from 01 Dec 2014.

##### **Movement of Stallions/Broodmares/Weanlings/Yearlings**

4. Attention is drawn of all concerned to Para 97 to 99 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India, effective from 01 Dec 2014.
5. Identification documents of all horses sheltered at a Breeding Establishment are liable to be inspected without prior notice. In case of identification documents not being available, action as deemed fit is liable to be taken against the concerned breeding establishment.

##### **Advertisement in Volume XV of the Register of Stallions in India**

6. Vol. XV of the Register of Stallions in India, is scheduled to be published in Mid-August 2018.
7. The publication would be of A4 size with photographs of stallions, on similar lines of Volume XIV, which was well received by the readers.

8. Charges for the advertisement are as under :-

9. Breeders who wish to advertise are requested to forward an artwork, preferably by email/CD/DVD so as to reach us by 30 June 2018.

### **Casualties and Movements**

10. As per Para 89 and 90 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India, casualties and movements of stallions, broodmares, yearlings, foals (even those whose Notification of Birth have not been submitted) must be reported within 90 days.

11. It may kindly be noted that in the event of casualties and movements not being reported within the stipulated time frame, a penalty of **Rs. 3,000/-** + (GST @ 18%) for each occurrence is liable to be imposed.
