RWITC Ltd. 2024 Annual Auction Sale

1. The RWITC Ltd 2024 Annual Auction Sale is scheduled to be conducted in Mumbai on **02 February 2024**.

- 3. Salient points of the RWITC Ltd 2024 Annual Auction Sale are as under:-
  - (a) The Sale will be held in Mumbai on 02 Feb 2024 commencing at 4.00 p.m.
  - (b) Entries to close at 5.00 p.m. on 31 Oct 2023
  - (c) Entry fee is Rs. 8,500/- + G.S.T as applicable per horse and payable at the time of entry.
  - (d) Entry into Sale Stables from 24 Jan to 28 Jan 2024.
  - (e) Organized Rolls to start on 29 Jan 2024.
  - (f) No pre-vetting of Horses.
  - (g) Private Sales will be allowed.
  - (h) Commission for lots sold in the Ring is 1%.
  - (i) Withdrawal fee is **Rs. 10,000/-.**

#### Certificates of Identity – Foals of 2023

5. Certificates of Identity of foals born in 2023 shall be issued either on-line or in paper form by the Panel Veterinarians authorized by the concerned Breeding Establishments **by 31 Oct 2023**. Such Certificates of Identity will be considered as being complete only for those horses which have been microchipped and the hair samples are received by SBAI and will be considered for registration. Certificates of Identity received after this date will incur late fees as under :-

(a) Certificates received by 30th Nov of the year of foaling. 2,000 per Certificate of Identity.

(b) Certificates received by 31st Dec of the year of foaling. ₹ 25,000/- per Certificate of Identity.

(c) Certificates received after 31st Dec of the year of foaling. At the discretion of the S.B.A.I. for a fee of  $\gtrless$  1,00,000/- per Certificate of Identity and subject to the reported parentage being validated.

#### Broodmares whose Covering Returns for 2023 are yet to be received

6. As per our records, Covering Returns of the following broodmares are yet to be received online. If they are received by **30 Sep 2023**, they will be considered for registration at a fee of ₹ 200/- each + GST @ 18% and thereafter till **30 Nov 2023** at a fee of ₹ 3,000/- each + GST @ 18%. It may however be noted that should the Stud Account be in debit at the time of receipt of the Covering Returns, the effective date of receipt would be the date on which the Stud Account has sufficient credit to defray the late fees :-

### COGGINS AND GLANDERS TESTING FOR FOALS OF 2022

1. All foals of 2022 arriving at any Racing Centre MUST have their blood samples drawn by the Panel veterinarian who have identified the foals of 2022. The serum samples should be tested by the Diagnostic Research Laboratory, situated in RWITC Ltd, Pune.

2. All foals of 2022 arriving at any race club premises in 2024 MUST travel with a valid Coggins and Glanders Negative Certificate apart from the Health Certificate.

### EQUINE INFLUENZA VACCINATION PROTOCOL FOR FOALS OF 2022

1. Veterinary Commission of Turf Authorities of India recommends the following Schedule of Fluvac Innovator EHV 4/1 Vaccine for Equine Influenza & EHV 4/1 vaccination for Foals born in 2022.

2. Two doses to be administered with an interval of 4 weeks in between as under

- (a) First dose 1<sup>st</sup> week of November 2023
- (b) Second dose 1<sup>st</sup> week of December 2023

3. It is further requested that the two doses of Fluvac vaccination for all the yearlings should be completed by the first week of December 2023.

4. All foals of 2022 should have received two doses of Equine Influenza Vaccine one month before their arrival at the Race club or Auction Sales and the same must be endorsed & certified in the respective passport.

5. Vaccination details must be duly endorsed in the respective Passport with the original sticker. Hand written batch number is not acceptable.
