

## **REQUIREMENTS FOR REGISTRATION OF A NEW BREEDING ESTABLISHMENTS**

- (1) Duly filled application form for Registration of a Breeding Establishment.
- (2) Minimum 10 acres of land with proof of ownership/title/authority or a copy of property extract. In case, the Breeding Establishment is in Proprietorship/ Partnership or owned by a Limited Companies the following documents may please be submitted:-
  - (i) **Proprietorship:-**
    - (a) A self-attested true copy of PAN Card
    - (b) Signature of the Proprietor verified by Bank (original).
    - (c) Appointment of an authorised agent and any change thereof under cover of letter submitted to SBAI in the prescribed form (original).
  - (ii) **Partnerships Firm:-**
    - (a) A self-attested true copy of Partnership deed duly registered with the competent authority and any amendment thereof.
    - (b) An extract of the firm registration issued by the Registrar of Firms showing names of partners including changes in constitution of partnership (as applicable) duly issued by Registrar of Firms.
    - (c) A self-attested true copy of PAN Cards of all the Partners.
    - (d) Signatures of the Partners verified by Bank (original).
    - (e) Appointment of an authorised agent/s and any change thereof must be submitted to Stud Book Authority of India in the prescribed form (original) duly signed by all Partners.
    - (f) In case of previous Partnership being dissolved, a self-attested true copy of Deed of Dissolution or retirement or re-constitution.
  - (iii) **Limited Companies:-**
    - (a) Memorandum and Articles of Association of the Company (original) self-attested.
    - (b) A true copy of Certificate of Registration of Company.
    - (c) A self-attested true copy of Form 32 duly registered and acknowledged which would include appointment and/or changes in directorship.
    - (d) Resolution of Board of Directors appointing an authorised agent and any change thereof must be submitted to SBAI in the prescribed form (original) duly signed by atleast two directors.
- (3) An official English translation of land record documents.
- (4) Plan attested by a Panel Veterinarian showing the number of stables, paddocks and other structures.
- (5) Sufficient number of stables for horses.
- (6) Adequate number of paddocks.
- (7) A minimum of six broodmares registered with the SBAI in the ownership of the Breeding Establishment/proprietors/partners.
- (8) A list of names of authorised person/s to sign on documents submitted to SBAI on prescribed form (Authority Form).
- (9) Availability of Veterinary and medical facilities. Furnish full details including name of the resident Veterinarian.
- (10) Detailed report of Panel Veterinarian about the Breeding Establishment.
- (11) Registration fee for Breeding Establishment Rs. 1,00,000/-.
- (12) Refundable deposit of Rs 2,00,000/-.
