ALL BREEDING ESTABLISHMENTS

1. In view of the Covid-19 situation and lockdowns over the country, postal and courier services had been disrupted since mid-March 2020.

2 Post / courier services have now resumed, so force majeure conditions don't apply any longer. Therefore, delays in submitting returns / samples shall incur late fees as per notified norms. In their own interest, breeders are advised to despatch all delayed returns / samples within next TEN DAYS at the latest.

Microchips – Foals of 2020

3. Some breeding establishments are yet to request for microchips for **foals of 2020**.

4. Breeding Establishments are requested to collate information of all births at their breeding establishments and request SBAI for microchips and hair sample envelopes.

5. Based on requests received from the breeding establishments, microchips shall be sent to them. Implantation of microchips may be carried out by the resident / contracted Veterinarian at the breeding establishments.

6. Hair samples of foals born in 2020 shall be collected from the foals and despatched to SBAI in the designated envelopes by the breeding establishments.

7. After receipt of samples by SBAI, they shall be handed over to the DNA laboratory.

List Of Stock Sheltered

8. Reference Para 86 of Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020.

9. A list of stock sheltered at each Breeding Establishment as on **01 Sep 2020** is due to be received by **30 Sep 2020**. All Breeding Establishments are requested to take note of the same.

10. Details of stock as per records of the Stud Book Authority of India may be viewed by Breeding Establishments using the online portal. Amendments required to the list may be informed to us via email.

Certificates of Identity – Foals of 2020

11. Certificates of Identity of foals born in 2020 shall be issued either on-line or in paper form by the Panel Veterinarians authorized by the concerned Breeding Establishments **by 31 Oct 2020**. Such Certificates of Identity will be considered as being complete only for those horses which have been microchipped and the hair sample is received by SBAI and will be considered for registration. Certificates of Identity received after this date will incur late fees as under :-

(a) **Certificates received by 30th Nov of the year of foaling.** ₹ 2,000/- per Certificate of Identity.

(b) **Certificates received by 31st Dec of the year of foaling.** ₹ 25,000/- per Certificate of Identity.

(c) **Certificates received after 31st Dec of the year of foaling.** At the discretion of the S.B.A.I. for a fee of ₹ 1,00,000/- per Certificate of Identity and subject to the reported parentage being validated.

Certificates of Identity – Foals of 2019

12. **104** Certificates of Identity of 2019-born foals are yet to be received.

13. Replies to some queries on major markings discrepancies noticed in the Certificates of Identity of foals of 2019 are awaited from the identifying Panel Veterinarians. The concerned Breeding Establishments are requested to inform the Panel Veterinarians to do the needful at the earliest to enable us to process the Certificates of Identity and facilitate preparation and despatch of passports well in time.

Passports – Foals of 2019

14. Passports of foals of 2019 are under preparation. Subsequent to the receipt of passports, all concerned are required to kindly identify the yearlings with the corresponding passports and revert to us in case any discrepancies are noticed.

Covering Certificates - 2020

15. Reference Para 55(a)(i) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020. Covering Certificates for the period 01 Feb to 31 Jul 2020 may be processed without any fee, provided they are submitted on-line by **31 Aug 2020**.

Confirmation of Funds Transfer Using RTGS / NEFT Facility

16. It is noticed that some Breeding Establishments do **not** send information about UTR No. when payments are made using the RTGS / NEFT facility towards their Stud Account or other services.

17. All concerned are requested to ensure that the details are informed to us.

Debit In Stud Accounts

18. Breeding Establishments whose Accounts are in debit are requested to clear the same at the earliest. Registration of documents submitted by Breeding Establishments whose accounts are in debit will be processed in terms of Para 121 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India, effective from 24 Feb 2020.
