ALL BREEDING ESTABLISHMENTS

Annual Auction Sale 2020 - Fodder Charges / Other Dues

1. Attention of all Vendors is invited to the Conditions of Sale, that they are liable to clear accounts of all lots entered by them in all respect including Commission, Taxes, Fodder Charges, Equine Hospital bills, etc by 28 Feb 2020, failing which, such accounts will be treated as outstanding dues with all attendant disqualifications like non-registration of returns, documents, etc. The Conditions of Sale (Para 50 to 52), may please be referred to.

Certificates of Identity

2. The last date for receipt of Certificates of Identity of foals born in 2019 was 31 Jan 2020. Only 745 of the expected 1133 Certificates of Identity have been received by that date. Certificates of Identity received till 30 Apr 2020 may be registered at a fee of ₹ 200/- each in accordance with Para 71(b) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India – effective from 01 Dec 2019.

3. **Statutory Publication - The Return of Mares 2019.** The Return of Mares 2019 is available in Mumbai and the Stud Book Department, Pune. The cost of the same is ₹ 250/-. Postage charges (*by Courier / Speed Post*) will be ₹ 200/- extra. Soft copies will be sent by email on request and postage charges will not be applicable.

4. Breeding Establishments may place their orders for the abovementioned publication enclosing the remittance or ensuring sufficient credit balance in their Stud Accounts.

Foals born in India from 01 Jan 2020 onwards

5. It may kindly be noted that with immediate effect, Breeding Establishments shall notify to the Stud Book Authority of India in writing by email or by letter, birth of all foals within **30 days of birth stating the name of the sire, dam, date of birth, colour and sex of the foal and place of birth.**

6. It may further be noted that **narrative and diagrammatic markings are NOT required** to be lodged on-line. It is mandatory for the Breeding Establishment to maintain a proper record of narrative and diagrammatic markings at its end.

7. The Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India (duly amended) will be circulated to all concerned in due course.

Branding Practices for identification and registration of Thoroughbred Horses in India

8. All concerned are requested to note that with effect from the foal-crop of 2020 branding of Thoroughbred Horses born in India is no longer a requirement for registration of horses by the Stud Book Authority of India (SBAI).
