## **RWITC Ltd Annual Auction Sale 2020 - Fodder Charges/Other Dues**

- 1. Attention of all Vendors is invited to the Conditions of Sale that they were liable to clear accounts of all Lots entered by them in all respects including commission, taxes, etc by **28 Feb 2020**. Bills for Feed charges and Equine hospital services, etc are being sent to all concerned.
- 2. All Breeding Establishments are requested to note that the amounts are being debited to their Stud Accounts.

### **Indemnity Bonds for Imported Horses**

3. Please note that the Indemnity Bond for Registration of Imported Horses needs to be prepared on a bond paper of value **Rs. 200/-** and submitted, duly notarised.

#### Foals born in India from 01 Jan 2020 onwards

- 4. It may kindly be noted that with immediate effect, Breeding Establishments shall notify to the Stud Book Authority of India in writing by email or by letter, birth of all foals within 30 days of birth stating the name of the sire, dam, date of birth, colour and sex of the foal and place of birth.
- 5. It may further be noted that **narrative and diagrammatic markings are NOT required** to be lodged on-line. It is mandatory for the Breeding Establishment to maintain a proper record of narrative and diagrammatic markings at its end.
- 6. The Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India (duly amended) may be viewed on our official website by clicking on the link

- 7. No branding of horses.
- 8. When a foal is born, the Breeding Establishment (BE) concerned shall report the birth of the foal within 30 days by a simple e-mail e.g. bay colt (Jan 5) by sire name ex dam name.
- 9. Narrative and diagrammatic markings in the Notification of Birth are not required to be lodged on-line. It is mandatory for the BE to maintain a proper record of the narrative and diagrammatic markings at its end.
- 10. The BE concerned shall collate information of all births at its farm on a monthly basis and request Stud Book Authority of India (SBAI) for microchips and hair sample envelopes.
- 11. Based on requests received from the BEs, microchips shall be sent to them. Implantation shall be carried out by the resident / contracted Veterinarian at the BE.
- 12. Hair samples shall be collected from the foal/s and dispatched to the SBAI in designated envelopes.
- 13. After receipt of samples by SBAI, they shall be dispatched to the DNA Laboratory on a monthly basis. The results received from the Laboratory will be compiled by SBAI. In case of discrepancies, or non-qualification, the BE concerned will be informed.
- 14. Certificates of Identity shall be issued on-line by a Panel Veterinarian (PV) by 31 October of the year of birth.
- 15. Rules pertaining to NOB and CI have been amended accordingly.
- 16. While verifying the Certificates of Identity, emphasis will be laid on the following two aspects:-
  - (a) Discrepancies between the diagram and description in the Certificate of Identity.
  - (b) Discrepancies within the description itself.

# **Incomplete Sale / Transfer Deeds**

17. All concerned are requested to note that Sale/Transfer deeds submitted to the Stud Book Authority of India for registration should be complete in all respects. Incomplete Sale/Transfer deeds are liable **NOT** to be registered. Blank forms may be downloaded from the website and the link is
