#### ALL BREEDING ESTABLISHMENTS

#### 2020 RWITC Ltd Annual Auction Sale

- 1. Entries for the captioned Sale close at **5.30 p.m. on Friday, 15 Nov 2019**.
- 2. Horses proposed to be entered in the Blue Section need to be informed to us well in advance and photographs of such horses will also need to be forwarded to us, the minimum resolution should be 300 dpi.
- 3. Horses which qualify to be featured in the Blue Section are one of these:-
  - (a) Horses entered by Breeding Establishments / Vendors which have produced at least one Indian Classic Winner.
  - (b) Lots out of a Group Winning dam.
  - (c) Lots, which are siblings to a Group Winner in India or abroad.
- 4. As done last year, brief audio visuals on all Blue Section entries will be shown on CCTV across all racing centres in India and will also be posted on <a href="mailto:rwitc.com">rwitc.com</a>.
- 5. The deadlines for receipt of photographs and videos is 30 Nov 2019.

#### Sale / Transfers of Young Horses

- 6. Breeding Establishments are requested to note that the Stud Book Authority of India will register Sales / Transfers of foals, weanlings, yearlings and 2YO's (which are still at breeding establishments and not registered with any recognized Turf Authority or Race Club provided the passport is lodged for endorsement).
- 7. Breeding Establishments are requested to kindly note this and forward Sale/Transfer forms of horses appropriately.

#### Fees for Registration of Breeding Stock

8. The registration fees for Breeding stock including GST @ 18% is as given below :-

#### **Casualties and Movements**

- 10. As per Para 89 and 90 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India, casualties and movements of stallions, broodmares, yearlings, foals (even those whose Notification of Birth have not been submitted) must be reported within 90 days.
- 11. It may kindly be noted that in the event of casualties and movements not being reported within the stipulated time frame, a penalty of **Rs. 3,000/- + Rs. 540/-** (GST @ 18%) for each occurrence is liable to be imposed.

#### Equine Influenza (EI) Vaccination Protocol for Two-Year-Olds

12. It may kindly be noted that as per the Protocol for Equine Influenza (EI) Vaccination, passports have to be produced to the visiting Veterinarians for necessary endorsements, etc.

13. Since in some cases the passports may not be available for endorsements, the Veterinary Commission suggests that the Veterinarian administering the vaccine may sign on a Verification Sheet mentioning the details of the horse viz. pedigree, date of vaccination, batch number, etc. For brevity, a format is appended as under:-

14. Subsequently, when the passports are received, the concerned Breeding Establishments may have these details endorsed on the passports by one of the Senior Veterinary Officers of the Race Clubs. In case of horses being entered for the Annual Auction Sale 2020, they could be endorsed by the Veterinary Officer on duty at the Mumbai Race Course.
