#### ALL BREEDING ESTABLISHMENTS

##### Covering Certificates for 2023

1. As done in previous years, Covering Returns for the year 2023 will need to be submitted on-line on <http://indianstudbook.com>. Breeding Establishments have already been given access to submit Covering Certificates for stallions standing at their respective farms.
2. Covering Certificates, if submitted in paper form will **NOT** be accepted.

##### RWITC Ltd. Annual Sale 2023 - Sales Venue Charges/ Fodder Charges/ Other Dues

3. All Vendors are hereby informed that they are liable to clear accounts of all Lots entered by them in all respects including commission, taxes, **sales venue charges, fodder charges, equine hospital bills, EIA/ Glanders charges**, etc. immediately failing which, such amounts will be treated as outstanding dues with all attendant disqualifications like non-registration of returns, documents, etc. Based on requests, the outstanding amounts have been debited to the respective Stud Accounts. Furthermore, the defaulters' names are liable to be reported to the Committee of RWITC Ltd, for further action.

##### Communication with the Stud Book Department

4. All breeding establishments are requested to correspond with the Stud Book Department on e-mail to the maximum extent to avoid delay in communication and to save on high postal / courier charges. The official e-mail ID is **[contact@indianstudbook.com](mailto:contact@indianstudbook.com)**.

## Stud Book Publications

6. **Return of Mares 2022.** The Return of Mares 2022 is available in Mumbai and the Stud Book Department, Pune. Hard / soft copies are available for ₹ 295/- (incl. GST @ 18%) each. In case hard copies are required, courier / postal charges (₹ 200/- in India) may also be remitted.

7. Breeding Establishments may place their order for the abovementioned publication enclosing their remittance or ensuring sufficient credit balance in their Stud Accounts.

9. **Horses STRUCK-OFF should NOT be used for breeding** till they are re-registered. Re-registration will be effected on receipt and acceptance of:-

- (a) Pink Form and passport.
- (b) Certificate of Identity from a Panel Veterinarian.
- (c) Registration fee specified in Rule 39(b) or Rule 42(f) as may be applicable.
- (d) DNA typing charges ₹ 8,000/- per horse.

10. Breeders intending to use the above mentioned horses for breeding should **ensure that written confirmation of re-registration** is received by them before the mares are covered.

## **Provision Of Write-ups**

11. For several years, Breeding Establishments have availed of our services to obtain write-ups of their bloodstock. Some of them have also had the write-ups in the form of Mini Catalogues.

12. The Stud Book Department will again endeavor to provide write-ups to all Breeding Establishments on a "first come first served" basis. The write-ups will be updated till 30 Apr 2023.

13. Standard write-ups will be charged at the rate of ₹ 750/- each. G.S.T. @18% will be extra as applicable.

## **Incomplete Sale / Transfer Deeds**

14. All concerned are requested to note that Sale/Transfer deeds submitted to the Stud Book Authority of India for registration should be complete in all respects. Incomplete Sale/Transfer deeds are liable **NOT** to be registered. Blank forms may be downloaded from the website and the link is
