#### ALL BREEDING ESTABLISHMENTS

#### Amendments to Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India

1. Paras 45 to 50 of the above Rules have been amended as under:-

*45. Broodmares and stallions are often put back into training after they have been registered for breeding. Intimation of broodmares and stallions put back into training must be given to the S.B.A.I. within 15 days of their leaving the breeding establishment.*

*46. If broodmares and stallions are put into training, their registration for breeding shall stand automatically suspended for upto two years subject to Rule 51 (below). Re-registration of such horses for breeding will be considered afresh by the S.B.A.I. on receipt of a fresh pink form duly completed in all respects. If and when a covering report is received, the registration will be re-activated and no registration fee will be payable.*

*47. The notification of coverings of mares put back in training as well as the results of those coverings MUST be intimated forthwith to the S.B.A.I. by breeding establishments along with the intimation of being put back in training.*

*48. Notwithstanding anything contained to the contrary in these Rules, a pregnant mare which is at the Stud SHALL not be permitted to race in any race meeting.*

*49. A pregnant mare that is no longer confirmed pregnant prior to the normal term of gestation or whose pregnancy goes to the normal term of gestation but does not result in a live foal, may return to training or racing after examination by a veterinarian ("satisfactory veterinary clearance").*

*50. A mare that has delivered a live foal SHALL not be permitted to race for the first year following the foal's birth date and SHALL only be permitted to return to racing after a satisfactory veterinary clearance*

## Covering Certificates for 2025

2. As done in previous years, Covering Returns for the year 2025 will need to be submitted on-line on <https://www.indianstudbook.com>. Breeding Establishments have already been given access to submit Covering Certificates for stallions standing at their respective farms.
3. Covering Certificates, if submitted in paper form will **NOT** be accepted.

## Communication with the Stud Book Department

4. All breeding establishments are requested to correspond with the Stud Book Department on e-mail to the maximum extent to avoid delay in communication and to save on high postal / courier charges. The official e-mail ID is **contact@indianstudbook.com**.
5. Changes in email Ids of Breeding Establishments may kindly be intimated. This would ensure timely receipt of notifications issued by the Stud Book Department. Circulars issued by the Stud Book Department are also available for view and download on

6. **Return of Mares 2024.** The Return of Mares 2024 is available in Mumbai and the Stud Book Department, Pune. Hard / soft copies are available for ₹ 295/- (incl. GST @ 18%) each. In case hard copies are required, courier / postal charges (₹ 200/- in India) may also be remitted.
7. Breeding Establishments may place their order for the abovementioned publication enclosing their remittance or ensuring sufficient credit balance in their Stud Accounts.

## Provision Of Write-ups

8. For several years, Breeding Establishments have availed of our services to obtain write-ups of their bloodstock. Some of them have also had the write-ups in the form of Mini Catalogues.
9. The Stud Book Department will again endeavor to provide write-ups to all Breeding Establishments on a “first come first served” basis. The write-ups will be updated till 30 Apr 2025.
10. Standard write-ups will be charged at the rate of ₹ 750/- each. G.S.T. @18% will be extra as applicable.

## Incomplete Sale / Transfer Deeds

11. All concerned are requested to note that Sale/Transfer deeds submitted to the Stud Book Authority of India for registration should be complete in all respects. Incomplete Sale/Transfer deeds are liable **NOT** to be registered. Blank forms may be downloaded from the website and the link is

## **Indemnity Bonds for Imported Horses**

12. Please note that the Indemnity Bond for Registration of Imported Horses needs to be prepared on a bond paper of value ₹ **1000/-** and submitted, duly notarised.
