Indemnity Bond for Registration of Imported Horses

1. It may please be noted that the Indemnity Bond for Registration of Imported Horses needs to be prepared on a bond paper of value ₹ 1,000/- and submitted, duly notarised.

5. **Mares STRUCK-OFF should NOT be used for breeding** till they are re-registered. Re-registration will be effected on receipt and acceptance of:-

- (a) Pink Form and passport.
- (b) Certificate of Identity from a Panel Veterinarian.
- (c) Registration fee specified in Rule 39(b) or Rule 42(f) as may be applicable.
- (d) DNA typing charges of ₹ 8,000/- per horse.

6. Breeders intending to use the above mentioned mares for breeding should **ensure that written confirmation of re-registration** is received by them before the mares are covered

7. The Return of Mares 2025 has been published.

8. The cost of the same is ₹ 250/- + GST @ 18%. Postage charges (by Courier / Speed Post) will be extra. Soft copies will be sent by email on request and postage charges will not be applicable.
