RWITC Ltd 2023 Annual Auction Sale

- 1. The RWITC Ltd. 2022 Annual Auction Sale is scheduled to be conducted in Mumbai on **06 February** and **07 February 2023**.

Entry fees payable by the Vendor

3. Entries received after 15 Oct and till the catalogue goes to Press - ₹15,000/-.

Certificates of Identity - Foals of 2022

- 4. As per our records, **854 foals of 2022** are living and of these, Certificates of Identity of **833 foals** have been received by 31 Oct 2022.
- 5. The remaining Certificates of Identity of **foals of 2022**, if submitted online or in paper form by **30 Nov 2022** and hair samples for DNA testing if received by the same date, may be processed in terms of Para 74(b) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India effective from 24 Feb 2020 at a fee **of ₹ 2,000/- + GST** @ **18% each**.
- 6. **Foals of 2022**, which may have died or were destroyed / put out of stud and their occurrences have not been notified to the Stud Book Authority of India, may please be reported immediately so as to keep our records up to date. Breeding Establishments are requested to return un-used microchips and relative hair sample envelopes of non-living foals of 2022.

Sale / Transfers of Young Horses

- 7. Breeding Establishments are requested to note that the Stud Book Authority of India will register Sales / Transfers of foals, weanlings, yearlings and 2YO's (which are still at breeding establishments and not registered with any recognized Turf Authority or Race Club provided the passport is lodged for endorsement).
- 8. Breeding Establishments are requested to kindly note this and forward Sale / Transfer forms of horses appropriately.

Fees for Registration of Breeding Stock

9. The registration fees for Breeding stock including GST @ 18% is as given below :-

Casualties and Movements

- 11. As per Para 88 and 89 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India effective from 24 Feb 2020, casualties and movements of stallions, broodmares, yearlings, foals (even those whose Notification of Birth have not been submitted) must be reported within 90 days.
- 12. It may kindly be noted that in the event of casualties and movements not being reported within the stipulated time frame, a penalty of ₹ 3,000/- + ₹ 540/- (GST @ 18%) for each occurrence is liable to be imposed.

Equine Influenza Vaccination of 2021 born foals

- 13. As requested by Dr. K. Venugopal Reddy, Chairman of the Veterinary Commission, Turf Authorities of India, all Breeding Establishments are hereby requested to undertake Equine influenza vaccination of 2021 born foals with two doses of Fluvac vaccine as under:-
 - (a) First dose 1st week of November 2022
 - (b) Second dose 1st week of December 2022

- 14. It is further requested by him that the two doses of Fluvac vaccination for all the yearlings should be completed by the first week of December 2022.
