#### ALL BREEDING ESTABLISHMENTS

##### Certificates of Identity – Foals of 2023

1. As per our records, **864 foals of 2023** are alive and of these, Certificates of Identity of **853 foals** have been received by 31 Oct 2023.
2. The remaining Certificates of Identity of **foals of 2023**, if received online or in paper form by **30 Nov 2023** and hair samples for DNA testing if received by the same date, may be processed in terms of Para 74(b) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India effective from 24 Feb 2020 at a fee of **₹ 2,000/- + GST @ 18% each**.
3. **Foals of 2023**, which may have died or were destroyed or have been put out of stud and their occurrences have not been notified to the Stud Book Authority of India, may please be reported immediately so as to keep our records up to date. Breeding Establishments are requested to return un-used microchips and relative hair sample envelopes of non-living foals of 2023.

##### Sale / Transfers of Young Horses

4. Breeding Establishments are requested to note that the Stud Book Authority of India will register Sales / Transfers of foals, weanlings, yearlings and 2YO's (*which are still at breeding establishments and not registered with any recognized Turf Authority or Race Club provided the passport is lodged for endorsement*).
5. Breeding Establishments are requested to kindly note this and forward Sale / Transfer forms of horses appropriately.

## Fees for Registration of Breeding Stock

6. The registration fees for Breeding stock including GST @ 18% is as given below :-

	Regn. fee	GST	Total
(a) Registration of a Breeding Establishment	- ₹ 1,00,000/-	+ 18,000/-	= ₹ 1,18,000/-
(b) Foreign-bred stallion	- ₹ 2,00,000/-	+ 36,000/-	= ₹ 2,36,000/-
(c) Foreign-bred broodmare	- ₹ 45,000/-	+ 8,100/-	= ₹ 53,100/-
(d) Indian-bred stallion	- ₹ 37,500/-	+ 6,750/-	= ₹ 44,250/-
(e) Indian-bred broodmare	- ₹ 7,500/-	+ 1,350/-	= ₹ 8,850/-

## Casualties and Movements

8. As per Para 88 and 89 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020, casualties and movements of stallions, broodmares, yearlings, foals (even those whose Notification of Birth have not been submitted) must be reported within 90 days.

9. It may kindly be noted that in the event of casualties and movements not being reported within the stipulated time frame, a penalty of ₹ 3,000/- + ₹ 540/- (GST @ 18%) for each occurrence is liable to be imposed.

## Coggins and Glanders Testing and Equine Influenza Vaccination Protocol – Foals of 2022

**COGGINS AND GLANDERS TESTING FOR FOALS OF 2022**

1. All foals of 2022 arriving at any Racing Centre MUST have their blood samples drawn by the Panel veterinarian who have identified the foals of 2022. The serum samples should be tested by the Diagnostic Research Laboratory, situated in RWITC Ltd, Pune.
2. All foals of 2022 arriving at any race club premises in 2024 MUST travel with a valid Coggins and Glanders Negative Certificate apart from the Health Certificate.

**EQUINE INFLUENZA VACCINATION PROTOCOL FOR FOALS OF 2022**

1. Veterinary Commission of Turf Authorities of India recommends the following Schedule of Fluvac Innovator EHV 4/1 Vaccine for Equine Influenza & EHV 4/1 vaccination for Foals born in 2022.
2. Two doses to be administered with an interval of 4 weeks in between as under
  - (a) First dose - 1<sup>st</sup> week of November 2023
  - (b) Second dose - 1<sup>st</sup> week of December 2023
3. It is further requested that the two doses of Fluvac vaccination for all the yearlings should be completed by the first week of December 2023.
4. All foals of 2022 should have received two doses of Equine Influenza Vaccine one month before their arrival at the Race club or Auction Sales and the same must be endorsed & certified in the respective passport.
5. Vaccination details must be duly endorsed in the respective Passport with the original sticker. Hand written batch number is not acceptable.
