ALL BREEDING ESTABLISHMENTS

Certificates of Identity - Foals of 2021

- 1. Certificates of Identity of foals born in 2021 shall be issued either on-line or in paper form by the Panel Veterinarians authorized by the concerned Breeding Establishments by 31 Oct 2021. Such Certificates of Identity will be considered as being complete only for those horses which have been microchipped and the hair samples are received by SBAI and will be considered for registration. Certificates of Identity received after this date will incur late fees as under:-
 - (a) Certificates received by 30th Nov of the year of foaling. $\ref{2,000}$ per Certificate of Identity.
 - (b) Certificates received by 31st Dec of the year of foaling. ₹ 25,000/- per Certificate of Identity.
 - (c) Certificates received after 31st Dec of the year of foaling. At the discretion of the S.B.A.I. for a fee of ₹ 1,00,000/- per Certificate of Identity and subject to the reported parentage being validated.

Microchips – Foals of 2021

- 2. Some breeding establishments are yet to request for microchips for **foals of 2021**.
- 3. Breeding Establishments are requested to collate information of all births at their breeding establishments and request SBAI for microchips and hair sample envelopes.
- 4. Based on requests received from the breeding establishments, microchips shall be sent to them. Implantation of microchips may be carried out by the resident / contracted Veterinarian at the breeding establishments.
- 5. Hair samples of foals born in 2021 shall be collected from the foals and despatched to SBAI in the designated envelopes by the breeding establishments.
- 6. After receipt of samples by SBAI, they shall be handed over to the DNA laboratory.

If they are received by 30 Nov 2021, they will be considered for registration at a fee of Rs. 3,000/- each + GST @ 18%. Refer para 55 (a)(iii) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India – effective from 24 Feb 2020. It may however be noted that should the Stud Account be in debit at the time of receipt of the Covering Certificates, the effective date of receipt would be the date on which the account has sufficient credit to defray the late fees.

COGGINS AND GLANDERS TESTING – FOALS OF 2020

Background - Normal Practice

1. All 2 year old horses that desire to enter a racing center have their blood samples drawn by the Veterinary Officer of a Turf Authority and tested by the Diagnostic Research Laboratory, situated in RWITC Ltd, Pune.

Situation in 2020 and 2021 in view of COVID-19 pandemic

- 2. Like last year, it will not be possible for Veterinary Officers of a Turf Authority of India to travel to Breeding Establishments for collection of blood samples of 2020 foals for Coggins and Glanders testing.
- 3. Keeping this pragmatic approach in mind, the Veterinary Commission of Turf Authorities of India decided to continue with last year's Protocol, keeping in mind its practical utility. The following may kindly be noted by the Breeding Establishments: -
 - (a) Panel Veterinarians who identified foals of 2020, microchipped them and submitted hair samples to the Stud Book Authority of India for DNA typing and parentage analysis may be entrusted the task of collection of blood samples for Coggins and Glanders testing of foals of 2020.
 - (b) It would be the discretion of the Breeding Establishment to use any other Panel Veterinarian.
 - (c) Breeding Establishments shall procure 10 ml. serum vacutainer test tube (red cap) for serum collection, collect blood samples and have the same sent for testing.
 - (d) Charges of NRCE may directly be remitted to it by the Breeding Establishment concerned.
 - (e) Since the time for blood collection is not fixed and has been relaxed this year as a special case, foals of 2020 may be sampled closer to the time when a horse intends to leave the Breeding Establishment.

Mandatory Requirement

- 4. All foals of 2020 arriving at any race club premises in 2022 **MUST** travel with a valid Coggins and Glanders Certificate apart from the Health Certificate.
- 5. All horses should have received the complete Primary schedule of Equine Influenza Vaccine one month before their arrival at the Race Club or Auction Sales and the same must be endorsed & certified in the respective passport (Ref: attached EQUINE INFLUENZA VACCINATION PROTOCOL FOR 2020 FOALS)

Conclusion

- 6. The Veterinary Commission of Turf Authorities of India is seized with the need to simplify and devise a pragmatic method for collection of samples before any foal of 2020 leaves a Breeding Establishment due to prevailing COVID-19 situation in the country.
- 7. Sending samples to NRCE of 2020 foals is unavoidable and as such this system is being adopted as a **one-off special case** so as not to jeopardize movements of these horses.

EQUINE INFLUENZA VACCINATION PROTOCOL FOR 2020 FOALS

Government of India has now permitted import of **Fluvac Innovator EHV 4/1 Vaccine** (Equine Influenza and EquineHerpes-4/1 viruses combination vaccine). This combo-vaccine protects against equine influenza and equine herpes viruses (EHV-1 and EHV-4) respiratory infections. This vaccine is particularly recommended by the Veterinary Commission of Turf Authorities of India (TAI) in yearlings at their breeding premises to avoid respiratory infections after their arrival in race clubs, as older racing horses are EH Virus shedding carriers. Also, this combo Fluvac Innovator vaccine has Equine Influenza virus component similar to **Calvenza-03 vaccine** which is being used since 2010, in total compliance with TAI directives. In view of this additional benefit, the Veterinary Commission recommends Fluvac Innovator EHV 4/1 vaccination of foals born in 2020 with immediate effect.

<u>Veterinary Commission of Turf Authorities of India Recommends the following Schedule</u> of Equine Influenza & EHV 4/1 vaccination for Foals born in 2020

- Fluvac Innovator EHV 4/1 Vaccine: <u>Two doses</u> to be administered with an interval of 4
 weeks in between and thereafter annual booster (given at race courses) for all foals born
 during 2020.
- 2. If **Calvenza-03** is to be used, the prevailing <u>Three doses</u> schedule should be strictly followed as in the past. It may be noted that this year being a transient period, foals of 2020 that have received Calevenza-03 are also allowed to enter Race Clubs in 2022.
- 3. It is absolutely mandatory that <u>either one</u> of the two vaccines (Calvenza-03 or Fluvac Innovator EHV 4/1 vaccine) be used during 2021. Mixing of two vaccines is strictly prohibited by the Veterinary Commission.
- 4. There should be at least **ONE MONTH interval period** from the last dose of Primary schedule vaccination to the date of arrival at the race clubs (can arrive at race clubs after the primary vaccination within 1 year).
- 5. Vaccination details must be duly endorsed in the respective Passport with the original sticker. Handwritten batch number is not acceptable.
