Certificates of Identity - Foals of 2022

- 5. Certificates of Identity of foals born in 2022 shall be issued either on-line or in paper form by the Panel Veterinarians authorized by the concerned Breeding Establishments **by 31**Oct 2022. Such Certificates of Identity will be considered as being complete only for those horses which have been microchipped and the hair samples are received by SBAI and will be considered for registration. Certificates of Identity received after this date will incur late fees as under:-
 - (a) Certificates received by 30th Nov of the year of foaling. $\ref{2,000}$ per Certificate of Identity.
 - (b) Certificates received by 31st Dec of the year of foaling. ₹ 25,000/- per Certificate of Identity.
 - (c) Certificates received after 31st Dec of the year of foaling. At the discretion of the S.B.A.I. for a fee of ₹ 1,00,000/- per Certificate of Identity and subject to the reported parentage being validated.

Broodmares whose Covering Returns for 2022 are yet to be received

6. Covering Returns of the following broodmares as per our records, have not been received on-line as on date. If they are received by **30 Nov 2022**, they will be considered for registration at a fee of ₹ 3,000/- each + GST @ 18%. Refer para 55 (a)(iii) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India – effective from 24 Feb 2020. It may however be noted that should the Stud Account be in debit at the time of receipt of the Covering Certificates, the effective date of receipt would be the date on which the account has sufficient credit to defray the late fees.

Equine Influenza Vaccination of 2021 born foals

- 13. As requested by Dr. K. Venugopal Reddy, Chairman of the Veterinary Commission, Turf Authorities of India, all Breeding Establishments are hereby requested to undertake Equine influenza vaccination of 2021 born foals with two doses of Fluvac vaccine as under:-
 - (a) First dose 1st week of November 2022
 - (b) Second dose 1st week of December 2022
- 14. It is further requested by him that the two doses of Fluvac vaccination for all the yearlings should be completed by the first week of December 2022.
