#### ALL BREEDING ESTABLISHMENTS

#### Certificates of Identity – Foals of 2024

1. Certificates of Identity of foals born in 2024 shall be issued either on-line or in paper form by the Panel Veterinarians authorized by the concerned Breeding Establishments **by 31 Oct 2024**. Such Certificates of Identity will be considered as being complete only for those horses which have been microchipped and the hair samples are received by SBAI and will be considered for registration. Certificates of Identity received after this date will incur late fees as under :-

(a) Certificates received by 30th Nov of the year of foaling. ₹ 2,000/- per Certificate of Identity.

(b) **Certificates received by 31st Dec of the year of foaling**. ₹ 25,000/- per Certificate of Identity.

(c) Certificates received after 31st Dec of the year of foaling. At the discretion of the S.B.A.I. for a fee of  $\gtrless$  1,00,000/- per Certificate of Identity and subject to the reported parentage being validated.

#### Broodmares whose Covering Returns for 2024 are yet to be received

3. Covering Returns of the following broodmares as per our records, have not been received on-line as on date. If they are received by **30 Nov 2024**, they will be considered for registration at a fee of ₹ 3,000/- each + GST @ 18%. Refer para 55 (a)(iii) of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India – effective from 24 Feb 2020. It may however be noted that should the Stud Account be in debit at the time of receipt of the Covering Certificates, the effective date of receipt would be the date on which the account has sufficient credit to defray the late fees.
