#### **RWITC Ltd. 2023 Annual Auction Sale**

- 1. The RWITC Ltd 2023 Annual Auction Sale is scheduled to be conducted in Mumbai on **06 February** and **07 February 2023**.

#### Charges payable by the Vendor

- Entry fee to the Catalogue is as under:-
  - (a) Entries received after 15 Aug and upto 15 Oct 2022 ₹ 10,000/-
  - (b) Entries received after 15 Oct and till the catalogue goes to Press ₹ 15,000/-

#### Microchips – Foals of 2022

- 4. Some breeding establishments are yet to request for microchips for **foals of 2022**.
- 5. Breeding Establishments are requested to collate information of all births at their breeding establishments and request SBAI for microchips and hair sample envelopes.
- 6. Based on requests received from the breeding establishments, microchips shall be sent to them. Implantation of microchips may be carried out by the resident / contracted Veterinarian at the breeding establishments.
- 7. Hair samples of foals born in 2022 shall be collected from the foals and despatched to SBAI in the designated envelopes by the breeding establishments.

#### **Incomplete Sale / Transfer Deeds**

8. All concerned are requested to note that Sale/Transfer deeds submitted to the Stud Book Authority of India for registration should be complete in all respects. Incomplete Sale/Transfer deeds are liable **NOT** to be registered. Blank forms may be downloaded from the website and the link is

### Broodmares whose Covering Returns for 2022 are yet to be received

9. As per our records, Covering Returns of the following broodmares are yet to be received on-line. If they are received by **30 Sep 2022**, they will be considered for registration at a fee of ₹ 200/- each + GST @ 18% and thereafter till **30 Nov 2022** at a fee of ₹ 3,000/- each + GST @ 18%. It may however be noted that should the Stud account be in debit at the time of receipt of the Covering Returns, the effective date of receipt would be the date on which the account has sufficient credit to defray the late fees.

# Stallions and Mares Not used For Breeding in 2022

- 11. Returns in respect of Mares, which have not been covered in 2022 need to be reported on-line.
- 12. Names of Stallions not used for breeding in 2022 may be informed by email.
- 13. If any of the horses listed in Para 9 and 10 (above) have died, been destroyed or have been put out of Stud, the details may please be intimated.

#### **List Of Stock Sheltered**

- 14. Reference Para 86 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India effective from 24 Feb 2020.
- 15. A list of stock sheltered at each Breeding Establishment as on **01 Sep 2022** is due to be received by **30 Sep 2022**. All Breeding Establishments are requested to take note of the same.
- 16. Details of stock as per records of the Stud Book Authority of India may be viewed by Breeding Establishments using the online portal. Amendments required to the list may be informed to us via email.

#### **Due Dates For Submission of Documents**

- 17. Attention of all concerned is drawn to the due date for submission of the following, which is **30 Sep 2022**:-
  - (a) Covering Certificates at a fee of ₹ 200/- per certificate + GST @ 18%.
  - (b) List of Stock Sheltered as on 01 Sep 2022.

#### Movement of Weanlings/Yearlings/Stallions and Broodmares

18. When horses move from one breeding establishment to another, their identification documents must travel along with them. In some cases, it is observed that this procedure is not being followed. This is an essential requirement and Breeding Establishments are requested to make a note of the same. In this connection, paras **96**, **97** and **98** of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020 may kindly be referred to.

## Passports – Foals of 2021

19. Passports of **492** foals of 2021 have been despatched to Breeding Establishments. Subsequent to the receipt of passports, all concerned are required to kindly identify the yearlings with the corresponding passports and revert to us in case any discrepancies are noticed. Remaining passports are under preparation.
