ALL BREEDING ESTABLISHMENTS

Microchips – Foals of 2024

1. Some breeding establishments are yet to request for microchips for **foals of 2024**.
2. Breeding Establishments are requested to collate information of all births at their breeding establishments and request SBAI for microchips and hair sample envelopes.
3. Based on requests received from the breeding establishments, microchips shall be sent to them. Implantation of microchips may be carried out by the resident / contracted Veterinarian at the breeding establishments.
4. Hair samples of foals born in 2024 shall be collected from the foals and despatched to SBAI in the designated envelopes by the breeding establishments.

Broodmares whose Covering Returns for 2024 are yet to be received

5. As per our records, Covering Returns of the following broodmares are yet to be received on-line. If they are received by **30 Sep 2024**, they will be considered for registration at a fee of ₹ 200/- each + GST @ 18% and thereafter till **30 Nov 2024** at a fee of ₹ 3,000/- each + GST @ 18%. It may however be noted that should the Stud account be in debit at the time of receipt of the Covering Returns, the effective date of receipt would be the date on which the account has sufficient credit to defray the late fees.

10. Reference Para 86 of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020.
11. A list of stock sheltered at each Breeding Establishment as on **01 Sep 2024** is due to be received by **30 Sep 2024**. All Breeding Establishments are requested to take note of the same.
12. Details of stock as per records of the Stud Book Authority of India may be viewed by Breeding Establishments using the online portal. Amendments required to the list may be informed to us via email.

Due Dates for Submission of Documents

13. Attention of all concerned is drawn to the due date for submission of the following, which is **30 Sep 2024**:-
 - (a) **Covering Certificates** at a fee of ₹ 200/- per certificate + GST @ 18%.
 - (b) **List of Stock Sheltered** as on 01 Sep 2024.

Movement of Weanlings/Yearlings/Stallions and Broodmares

14. When horses move from one breeding establishment to another, their identification documents must travel along with them. In some cases, it is observed that this procedure is not being followed. This is an essential requirement and Breeding Establishments are requested to make a note of the same. In this connection, paras **96, 97** and **98** of the Rules and Requirements for Registration of Thoroughbred and Half-bred Horses in India - effective from 24 Feb 2020 may kindly be referred to.

Incomplete Sale / Transfer Deeds

15. All concerned are requested to note that Sale/Transfer deeds submitted to the Stud Book Authority of India for registration should be complete in all respects. Incomplete Sale/Transfer deeds are liable **NOT** to be registered. Blank forms may be downloaded from the website and the link is <https://www.indianstudbook.com/download.php>
